I hereby agree to abide by the rules, regulations and policies of Hastings Country Club now in effect or hereafter adopted. I understand that the stated initial payment (differs from an start-up initiation fee) required for my/our membership is due and payable in full upon submission of this application, unless I choose the monthly option, which will need to be paid in full no later than July 30, 2010 and will include an 8% surcharge. I further understand this initial payment and all other dues paid are non-refundable should I choose not to be/become a member of Hastings Country Club. Charges for stock purchase will be incurred/applied once your application for membership is accepted. Stock issued is non-transferable but is fully refundable. You will be added to the repayment list and refunded when the club is financially able. Members will be refunded in the order they are added to the list. I hereby certify that the information in this application is true and correct and authorize Hastings Country Club to make credit inquiries that may be necessary to process this application.

In addition to the lump sum payment, I hereby agree to pay dues, liabilities (including monthly minimum spending requirements, which includes food ONLY, not beverages) and any other charges, which may be incidental to membership to Hastings Country Club of Dakota County, on an annual or monthly basis. As part of the membership agreement, I hereby agree to maintain my membership at Hastings Country Club and pay all dues, liabilities and other charges including but not limited to club improvement fees, for the 2010 golf season ending September 30, 2010. I further agree and understand that thereafter, my dues, liabilities and any other charges, are subject to change at the discretion of the Board of Directors.

Renewal of my membership at Hastings Country Club of Dakota County shall continue each and every year until formal written notice of resignation is given. All past due accounts shall accrue a 1.5% finance charge per month if not paid in full. The Club sends out statements the first week of the month either via email or USPS. The Club is not responsible for accounts becoming past due because a statement was not received. If a statement is returned to us either by email or by the post office, we will attempt to get it to you another way. All member accounts that become 60 days past due will be suspended until paid in full. Balances are due upon receipt. I also agree to indemnify and hold Hastings Country Club Dakota County harmless from any and all expenses reasonably incurred by it, including fees and expenses of attorneys and collection agencies, in collection of any sums owed to Hastings Country Club by the undersigned. The amount of the finance charge is subject to change without notice, at the discretion of the Board of Directors.
